This Stipulation of Settlement (the "Stipulation") is made and entered into by and between 1 2 Lead Plaintiff New York Hotel Trades Council & Hotel Association of New York City, Inc. Pension 3 Fund ("Lead Plaintiff" or the "Fund"), and proposed class representative Sheet Metal Workers' 4 Pension Plan of Southern California, Arizona and Nevada ("Sheet Metal Workers' Fund" and 5 together with Lead Plaintiff, the "Plaintiffs"), on behalf of themselves and the proposed Class 6 (defined below), on the one hand, by and through their counsel of record in the Action (as defined 7 herein), and Defendants Impax Laboratories, LLC (formerly known as Impax Laboratories, Inc.) 8 ("Impax" or the "Company"), George Frederick Wilkinson, Dr. Larry Hsu, Dr. Carole Ben-Maimon, 9 and Bryan M. Reasons (collectively, "Defendants") on the other hand, by and through their counsel 10 of record in the Action.

All words or terms used herein that are capitalized shall have the meanings ascribed to those
words or terms as set forth herein and in ¶1 hereof entitled "Definitions."

I.

THE LITIGATION

This is a consolidated securities class action brought against Defendants by the Fund
individually and on behalf of all persons or entities who purchased or otherwise acquired Impax
common stock or 2% Convertible Senior Notes between February 20, 2014 and August 9, 2016,
inclusive (the "Class Period").

On November 11, 2016, the initial complaint in *Fleming v. Impax Laboratories Inc., et al.*,
No. 4:16-cv-06557, was filed in the United States District Court for the Northern District of
California (the "Court"). ECF No. 1. On January 9, 2017, the Fund moved for appointment as lead
plaintiff and approval of its selection of counsel. ECF No. 13.

On February 15, 2017, the Court issued an order appointing the Fund as lead plaintiff and
approving its selection of Robbins Geller Rudman & Dowd LLP as lead counsel. ECF No. 29.

Lead Plaintiff filed the Amended Complaint for Violation of the Federal Securities Laws
("Amended Complaint") on April 17, 2017, alleging violations of §§10(b) and 20(a) of the Securities
Exchange Act of 1934 ("1934 Act"). ECF No. 32.

On June 1, 2017, Defendants moved to dismiss the Amended Complaint and filed a Request
for Judicial Notice. ECF Nos. 50-51. Lead Plaintiff filed its opposition to the motion to dismiss and

its request for judicial notice on July 17, 2017. ECF Nos. 52-53. The Court took the motion to
 dismiss under submission on September 11, 2017, and dismissed the Amended Complaint with leave
 to amend on September 7, 2018. ECF Nos. 58, 66. Lead Plaintiff filed its Second Amended
 Complaint for Violation of the Federal Securities Laws (the "SAC") on October 26, 2018. ECF No.
 71.

Defendants moved to dismiss the SAC on December 6, 2018 (ECF No. 72), and Lead
Plaintiff filed its opposition on January 17, 2019 (ECF No. 73). Defendants filed their reply on
February 7, 2019, and the Court heard oral argument on the motion on May 2, 2019. ECF Nos. 7677. On August 12, 2019, the Court dismissed the SAC with prejudice ("August 12 Order"). ECF
No. 86.

Lead Plaintiff appealed the August 12 Order. *See* ECF No. 87. On February 14, 2020, the
Fund filed its opening brief. App. ECF No. 10. Defendants filed their answering brief on May 15,
2020, and the Fund filed its reply brief on August 4, 2020. App. ECF Nos. 15, 25. The Ninth
Circuit heard oral argument on December 9, 2020, and took the matter under submission. *See* App.
ECF No. 40.

On January 11, 2021, the Ninth Circuit issued its memorandum disposition, affirming in part
and reversing in part the August 12 Order. App. ECF No. 41-1. On January 25, 2021, Defendants
filed their petition for panel rehearing and rehearing *en banc*. App. ECF No. 42.

On February 8, 2021, Sheet Metal Workers' Fund filed a motion to intervene with the Ninth
Circuit, in which Lead Plaintiff joined. App. ECF No. 43. Defendants filed their response to the
motion on February 18, 2021, and the Funds filed their reply on February 25, 2021. App. ECF Nos.
45-46.

On March 24, 2021, the Ninth Circuit denied Defendants' petition for rehearing. App. ECF
No. 47. The Ninth Circuit also denied the Sheet Metal Workers' Fund's motion to intervene
"without prejudice to seek leave to intervene on remand." App. ECF No. 48 at 2.

26 The mandate issued on April 1, 2021. App. ECF No. 50.

27 On April 5, 2021, Plaintiffs filed their motion to intervene with the Court. ECF No. 93. On

28 April 19, 2021, Defendants moved to dismiss the SAC arguing that Plaintiffs lacked standing. ECF

1 No. 96. On May 17, 2021, the Lead Plaintiff filed its opposition to Defendants' motion to dismiss, 2 and Defendants filed their opposition to the Plaintiffs' motion to intervene. ECF Nos. 101-102. On 3 June 1, 2021, the Plaintiffs and Defendants filed their replies in further support of their respective 4 motions. ECF Nos. 106-107. The Court took the matters under submission on June 25, 2021. ECF 5 No. 108.

6 On September 17, 2020, the parties attended a full-day mediation with the Hon. Layn Phillips 7 (Ret.). The parties negotiated in good faith but did not reach an agreement, and litigation continued. 8 The parties continued their negotiation efforts while litigating the Action. After extensive 9 negotiations, the parties reached an agreement-in-principle to settle the case on the terms set forth 10 herein.

11

II. PLAINTIFFS' CLAIMS AND BENEFITS OF SETTLEMENT

12 Plaintiffs believe that the claims asserted in the Action have merit and that the evidence 13 developed to date supports the claims asserted. However, Plaintiffs and Lead Counsel recognize and 14 acknowledge the expense and length of continued proceedings necessary to prosecute the Action 15 through class certification, discovery, summary judgment, and trial (and any possible appeals). 16 Plaintiffs and Lead Counsel also have taken into account the uncertain outcome and the risk of any 17 litigation, especially in complex actions such as the Action, as well as the difficulties and delays 18 inherent in such litigation. For example, the Court to date has only upheld Plaintiffs' loss causation 19 allegations with respect to the earliest four corrective disclosures. Lead Counsel also are mindful of 20 the inherent problems of proof and the possible defenses to the claims alleged in the Action. Based 21 on their evaluation, Plaintiffs and Lead Counsel believe that the Settlement set forth in this 22 Stipulation confers substantial monetary benefits upon the Class and is in the best interests of the 23 Class.

24

III. **DEFENDANTS' DENIALS OF LIABILITY**

25 Defendants have denied and continue to deny each and all of the claims, contentions, and 26 allegations made by Lead Plaintiff in the Action. They have expressly denied and continue to deny 27 that they have violated the federal securities laws or any other laws, or have otherwise misled 28 investors as alleged in the Action. any of the Defendants made any material misstatements or omissions or engaged in any fraudulent
 scheme; and that any member of the Class has suffered damages resulting from the conduct alleged
 in the Action. In addition, Defendants maintain that they have meritorious defenses to the claims
 alleged in the Action.

Nonetheless, Defendants have concluded that further litigation could be protracted,
burdensome, expensive, and distracting. Defendants also have taken into account the uncertainty,
risks, and costs inherent in any litigation, especially in complex cases such as this Action.
Defendants have, therefore, determined that it is desirable and beneficial to them that the Action be
fully, finally, and forever resolved, discharged, and settled in the manner and upon the terms and
conditions set forth in this Stipulation.

NOW THEREFORE, without any concession by Plaintiffs that the Action lacks merit, and 11 12 without any concession by Defendants of any liability or wrongdoing or lack of merit in their 13 defenses, it is hereby STIPULATED AND AGREED, by and among the parties to this Stipulation 14 ("Parties"), through their respective attorneys, subject to approval by the Court pursuant to Rule 15 23(e) of the Federal Rules of Civil Procedure, that, in consideration of the benefits flowing to the 16 Parties hereto, all Released Claims (including Unknown Claims) and all Released Defendants' 17 Claims (including Unknown Claims), as against all Released Parties, shall be fully, finally, and 18 forever compromised, settled, released, discharged, and dismissed with prejudice, and without costs 19 (except as provided in the Stipulation), upon and subject to the following terms and conditions:

1. Definitions

As used in this Stipulation, the following terms shall have the meanings set forth below.

1.1 "Action" means the civil action captioned *Fleming v. Impax Laboratories Inc., et al.*,
No. 4:16-cv-06557-HSG (N.D. Cal.), pending in the United States District Court for the Northern
District of California before the Honorable Haywood S. Gilliam, Jr.

4 1.4 "Class" or "Class Member" means all Persons that purchased or acquired Impax 5 common stock or 2% Convertible Senior Notes between February 20, 2014 and August 9, 2016, 6 inclusive. Excluded from the Class are: (i) Defendants; (ii) members of the immediate families of 7 the Individual Defendants; (iii) Impax's subsidiaries; (iv) the officers and directors of Impax during 8 the Class Period; (v) any entity in which any Defendant has a controlling interest; and (vi) the legal 9 representatives, heirs, successors and assigns of any such excluded person or entity. Also excluded 10 from the Class will be any Person who timely and validly seeks exclusion from the Class.

- 11 1.5 "Class Period" means the period from February 20, 2014 through August 9, 2016, inclusive. 12
- 13 1.6 "Defendants" means Impax, George Frederick Wilkinson, Dr. Larry Hsu, Dr. Carole 14 Ben-Maimon, and Bryan M. Reasons.
 - 1.7 "Defendants' Counsel" means the law firm of Latham & Watkins LLP.
- 16 1.8 "Effective Date" means the date upon which the Settlement shall have become 17 effective, as set forth in ¶7.1, below.
- 1.9 18 "Escrow Account" means the separate escrow account designated and controlled by 19 Lead Counsel into which the Settlement Amount will be deposited for the benefit of the Class.
 - 1.10 "Escrow Agent" means Lead Counsel.

- 21 1.11 "Fee and Expense Application" means Lead Counsel's application for an award of 22 attorneys' fees and litigation expenses, and any award to Plaintiffs pursuant to 15 U.S.C. §78u-23 4(a)(4) of the PSLRA in connection with their representation of the Class.
- 24 1.12 "Final" means, with respect to any order of court, including, without limitation, the 25 Judgment, that such order represents a final and binding determination of all issues within its scope 26 and is not subject to further review on appeal or otherwise. Without limitation, an order becomes 27 "Final" when: (i) no appeal has been filed and the prescribed time for commencing any appeal has 28 expired; or (ii) an appeal has been filed and either (a) the appeal has been dismissed and the AMENDED STIPULATION OF SETTLEMENT - 4:16-cv-06557-HSG - 5

prescribed time, if any, for commencing any further appeal has expired, or (b) the order has been 1 2 affirmed in all material respects and the prescribed time, if any, for commencing any further appeal has expired. For purposes of this definition of "Final," an "appeal" includes any motion to alter or 3 4 amend under Rule 52(b) or Rule 59(e) of the Federal Rules of Civil Procedure, any appeal as of 5 right, discretionary appeal, interlocutory appeal, petition for writ of certiorari, or other proceeding involving writs of certiorari or mandamus, and any other proceedings of like kind. However, any 6 7 appeal or proceeding seeking subsequent judicial review pertaining solely to the Plan of Allocation, 8 or to the Court's award of attorneys' fees or expenses, shall not in any way delay or affect the time 9 set forth above for the Judgment to become Final or otherwise preclude the Judgment from becoming Final. 10 11 1.13 "Individual Defendants" means former Impax officers George Frederick Wilkinson, Dr. Larry Hsu, Dr. Carole Ben-Maimon, and Bryan M. 13 1.26 "Related Persons" means, with respect to the Defendants, each and all of their 14 respective present or former parents, subsidiaries, affiliates, successors and assigns, and each and all 15 of the present or former officers, directors, employees, employees, attorneys, accountants, financial 16 advisors, commercial bank lenders, insurers, reinsurers, investment bankers, representatives, general 17 and limited partners and partnerships, heirs, executors, administrators, successors, affiliates, agents, 18 spouses, associates, and assigns of each or any of them or any trust of which any Defendant is the 19 settlor or which is for the benefit of any Defendant and any entity in which any such Defendant has a 20 controlling interest.

21 1.27 "Released Claims" means any and all claims, rights, liabilities, and causes of action 22 of every nature and description, including both known claims and Unknown Claims, whether 23 contingent or absolute, mature or unmature, discoverable or undiscoverable, liquidated or 24 unliquidated, accrued or unaccrued, including those that are concealed or hidden, regardless of legal 25 or equitable theory, that Lead Plaintiff or any other member(s) of the Class asserted or could have 26 asserted in any forum that both (i) arise out of, are based upon, or are related in any way to the 27 allegations, transactions, facts, events, matters, occurrences, disclosures, statements, representations, 28 or omissions referred to in the Action, and (ii) relate to the purchase or acquisition of Impax AMENDED STIPULATION OF SETTLEMENT - 4:16-cv-06557-HSG

- 13 1.41 "Unknown Claims" means any and all Released Claims that Plaintiffs or any other 14 Class Member do not know or suspect to exist in his, her, or its favor at the time of the release of the 15 Released Defendant Parties, and any and all Released Defendants' Claims that any Defendant does 16 not know or suspect to exist in his, her or its favor, which if known by him, her or it, might have 17 affected his, her or its decision to enter into this Settlement, execute this Stipulation, and agree to all the various releases set forth herein, or might have affected his, her or its decision not to object to 18 19 this Settlement or not exclude himself, herself or itself from the Class. Unknown Claims include, 20 without limitation, those claims in which some or all of the facts composing the claim may be 21 unsuspected, undisclosed, concealed, or hidden. With respect to any and all Released Claims and 22 Released Defendants' Claims, the Released Parties stipulate and agree that, upon the Effective Date, 23 Plaintiffs and Class Members (as regards the Released Claims) and the Defendants (as regards the 24 Released Defendants' Claims) shall expressly waive and relinquish, and each Class Member shall be 25 deemed to have and by operation of law and of the Judgment shall have, expressly waived and 26 relinquished, to the fullest extent permitted by law, any and all provisions, rights and benefits 27 conferred by California Civil Code §1542, or any law of any state or territory of the United States, or

principle of common law or of international or foreign law, which is similar, comparable, or
 equivalent to Cal. Civ. Code §1542, which provides:

A general release does not extend to claims which the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.

2. The Settlement

a. The Settlement Fund

7 In full settlement of the Released Claims, Defendants shall cause the Settlement 2.1 8 Amount to be transferred to an account controlled by the Escrow Agent no later than seventeen (17) 9 calendar days after the later of: (i) entry of the Preliminary Approval Order; (ii) the certification of 10 the Class and appointment of one or more of the Plaintiffs and Lead Counsel as counsel for the 11 Class; and (iii) the provision to Defendants of information necessary to effectuate a payment of 12 funds, including the beneficiary account name, the U.S. bank name, address, account number and 13 ABA bank code (*i.e.*, routing number), and the payment reference (the later of the foregoing (i), (ii), 14 and (iii) being hereinafter referred to as the "Payment Date"). These funds, together with any 15 interest and income earned thereon once transferred, shall constitute the Settlement Fund. 16

2.2 If the entire Settlement Amount is not deposited into the Escrow Account by the
Payment Date, Lead Counsel may terminate the Settlement but only if: (i) Defendants have received
from Lead Counsel written notice of Lead Counsel's intention to terminate the Settlement; and
(ii) the entire Settlement Amount is not transferred to the Escrow Account within three (3) business
days after Lead Counsel has provided such written notice.

b. The Escrow Agent

2.3 The Escrow Agent shall invest the Settlement Fund deposited pursuant to ¶2.1 hereof
in instruments backed by the full faith and credit of the United States Government or fully insured by
the United States Government or an agency thereof and shall reinvest the proceeds of these
instruments as they mature in similar instruments at their then-current market rates. All costs and
risks related to the investment of the Settlement Fund in accordance with the guidelines set forth in
this paragraph shall be borne by the Settlement Fund.

2.4 The Escrow Agent shall not disburse the Settlement Fund except: (a) as provided in
 the Stipulation; (b) by an order of the Court; or (c) with the written agreement of counsel for the
 Settling Parties.

2.5 Subject to further order(s) and/or directions as may be made by the Court, or as
provided in the Stipulation, the Escrow Agent is authorized to execute such transactions as are
provided for under the terms of the Stipulation. The Released Parties shall have no responsibility
for, interest in, or liability whatsoever with respect to, the actions of the Escrow Agent, or any
transaction executed by the Escrow Agent.

9 2.6 All funds held by the Escrow Agent shall be deemed and considered to be in *custodia*10 *legis* of the Court, and shall remain subject to the jurisdiction of the Court, until such time as such
11 funds shall be distributed pursuant to the Stipulation and/or further order(s) of the Court.

2.7 12 Prior to the Effective Date and without further order of the Court, up to \$500,000 of 13 the Settlement Fund may be used by Lead Counsel to pay reasonable costs and expenses actually 14 incurred in connection with providing notice to the Class, locating Class Members, soliciting claims, 15 assisting with the submission of claims, processing Proofs of Claim, administering and distributing 16 the Net Settlement Fund to Authorized Claimants, and paying escrow fees and costs, if any ("Notice 17 and Administration Expenses"). After the Effective Date, Lead Counsel may pay all further 18 reasonable Notice and Administration Expenses, regardless of amount, without further order of the 19 Court.

20

c. Taxes

21 2.8 (a) The Settling Parties agree to treat the Settlement Fund as being at all times a 22 "Qualified Settlement Fund" within the meaning of Treasury Regulation §1.468B-1. In addition, the 23 Escrow Agent shall timely make such elections as necessary or advisable to carry out the provisions 24 of this ¶2.8, including the "relation-back election" (as defined in Treasury Regulation §1.468B-1) 25 back to the earliest permitted date. Such elections shall be made in compliance with the procedures 26 and requirements contained in such regulations. It shall be the responsibility of the Escrow Agent to 27 timely and properly prepare and deliver the necessary documentation for signature by all necessary 28 parties, and thereafter to cause the appropriate filing to occur.

(b) 1 For the purpose of §1.468B of the Internal Revenue Code of 1986, as 2 amended, and the regulations promulgated thereunder, the "administrator" shall be the Escrow 3 Agent. The Escrow Agent shall timely and properly file all informational and other tax returns necessary or advisable with respect to the Settlement Fund (including, without limitation, the returns 4 5 described in Treasury Regulation §1.468B-2(k)). Such returns (as well as the election described in ¶2.8(a) hereof) shall be consistent with this ¶2.8 and in all events shall reflect that all Taxes 6 7 (including any estimated Taxes, interest, or penalties) on the income earned by the Settlement Fund 8 shall be paid out of the Settlement Fund as provided in ¶2.8(c) hereof.

9 (c) All (a) Taxes (including any estimated Taxes, interest, or penalties) arising 10 with respect to the income earned by the Settlement Fund, including any Taxes or tax detriments that may be imposed upon the Released Defendant Parties or their counsel with respect to any income 11 12 earned by the Settlement Fund for any period during which the Settlement Fund does not qualify as a 13 "Qualified Settlement Fund" for federal or state income tax purposes, and (b) Tax Expenses, 14 including expenses and costs incurred in connection with the operation and implementation of this 15 ¶2.8 (including, without limitation, expenses of tax attorneys and/or accountants and mailing and 16 distribution costs and expenses relating to filing (or failing to file) the returns described in this ¶2.8), 17 shall be paid out of the Settlement Fund; in all events the Released Defendant Parties and their 18 counsel shall have no liability or responsibility for the Taxes or the Tax Expenses. Further, Taxes 19 and Tax Expenses shall be treated as, and considered to be, a cost of administration of the Settlement 20 Fund and shall be timely paid by the Escrow Agent out of the Settlement Fund without prior order 21 from the Court, and the Escrow Agent shall be obligated (notwithstanding anything herein to the 22 contrary) to withhold from distribution to Authorized Claimants any funds necessary to pay such 23 amounts, including the establishment of adequate reserves for any Taxes and Tax Expenses (as well 24 as any amounts that may be required to be withheld under Treasury Regulation §1.468B-2(1)(2)); 25 neither the Released Defendant Parties nor their counsel are responsible nor shall they have any 26 liability therefor. The Settling Parties hereto agree to cooperate with the Escrow Agent, each other, 27 and their tax attorneys and accountants to the extent reasonably necessary to carry out the provisions 28 of this $\P2.8$.

d. **Termination of Settlement**

2 2.9 In the event the Stipulation is not approved or is terminated, canceled, or fails to 3 become effective for any reason, including, without limitation, in the event the Stipulation is not 4 approved or Judgment is reversed or vacated following any appeal taken therefrom, the Settlement 5 Fund (including accrued interest), less expenses actually incurred or due and owing for Notice and 6 Administration Expenses, Taxes or Tax Expenses pursuant to ¶12.7 or 2.8, shall be refunded 7 pursuant to ¶6.2 and 7.4 and written instructions from Defendants' Counsel to the party, parties or 8 insurers that paid the Settlement Amount within twenty-one (21) days from the date of the notice 9 from counsel for Defendants pursuant to $\P7.4$.

3. **Preliminary Approval Order and Settlement Hearing**

11 3.1 Promptly after execution of the Stipulation, Lead Counsel shall submit the Stipulation 12 together with its exhibits (the "Exhibits") to the Court and shall apply for entry of an order (the 13 "Preliminary Approval Order"), requesting, inter alia, the preliminary approval of the Settlement set 14 forth in the Stipulation, certification of the Class and appointment of Lead Counsel as counsel for the 15 Class for settlement purposes, and approval for the mailing of the Notice and publication of the 16 Summary Notice, in the forms of Exhibits A-1 and A-3, respectively, attached hereto. The Notice 17 shall include the general terms of the Settlement set forth in the Stipulation, the proposed Plan of 18 Allocation, the general terms of the Fee and Expense Application, and the date of the Settlement 19 Hearing.

20 3.2 Lead Counsel shall request that, after notice is given to the Class, the Court hold the 21 Settlement Hearing and approve the Settlement of the Action as set forth herein. At or after the 22 Settlement Hearing, Lead Counsel also shall request that the Court approve the proposed Plan of 23 Allocation and the Fee and Expense Application.

24

4. Releases

25 4.1 Upon the Effective Date, Plaintiffs and each of the Class Members (who have not 26 validly opted out of the Class), on behalf of themselves, and their respective former and present 27 officers, directors, employees, agents, affiliates, parents, subsidiaries, insurers, reinsurers, heirs, 28 executors, administrators, predecessors, successors, and assigns in their capacities as such, shall be AMENDED STIPULATION OF SETTLEMENT - 4:16-cv-06557-HSG - 13

deemed to have, and by operation of law and of the Judgment shall have, fully, finally, and forever

4.2 Upon the Effective Date, Plaintiffs and each of the Class Members (who have not
validly opted out of the Class) shall be permanently barred and enjoined from the institution,
maintenance, prosecution, or enforcement against any Released Defendant Party, in any state or
federal court or arbitral forum, or in the court of any foreign jurisdiction, of any and all Released
Claims (including, without limitation, Unknown Claims). The Court shall retain exclusive
jurisdiction to interpret and enforce the permanent injunction described in this paragraph.

4.3 The Proof of Claim to be executed by Class Members shall release all Released
Claims against the Released Defendant Parties and shall be substantially in the form contained in
Exhibit A-2 attached hereto; provided, however, that the failure of a Class Member to submit such
Proof of Claim shall have no effect on the provisions of the foregoing ¶¶4.1 and 4.2, inclusive,
which shall remain in full force and effect as to each of the Class Members (who have not validly
opted out of the Class) irrespective of any lack of submission of a Proof of Claim.

4.4 Upon the Effective Date, each of the Released Defendant Parties, on behalf of
themselves, and their respective former and present officers, directors, employees, agents, affiliates,
parents, subsidiaries, insurers, reinsurers, heirs, executors, administrators, predecessors, successors,
and assigns in their capacities as such, shall be deemed to have, and by operation of the Judgment
shall have, fully, finally, and forever released, relinquished, and discharged the Released Plaintiff
Parties, including Plaintiffs' Counsel, from all Released Defendants' Claims (including, without
limitation, Unknown Claims).

5. Administration and Calculation of Claims, Final Awards, and Supervision and Distribution of the Settlement Fund

The Claims Administrator, subject to such supervision and direction of the Court as
 may be necessary or as circumstances may require, shall provide notice of the Settlement to the

Class, shall administer and calculate the claims submitted by Class Members, and shall oversee
 distribution of the Net Settlement Fund to Authorized Claimants.

3	5.2 Within ten (10) calendar days after the Court enters the Preliminary Approval Order,		
4	Defendants and their counsel shall provide Lead Counsel or the Claims Administrator, without any		
5	charge to Plaintiffs or the Class, record shareholder lists, as appropriate for providing notice to the		
6	Class. The parties shall determine an appropriate electronic format for provision of this information.		
7	5.3 In accordance with the schedule set forth in the Preliminary Approval Order, Lead		
8	Counsel will cause the Notice, substantially in the form of Exhibit A-1 attached hereto, and a Proof

10	Administrator to all shareholders of record, or nominees. The Notice and Proof of Claim shall also

13	also be published once in the national edition of <i>The Wall Street Journal</i> and once over a national		
14	newswire service. The cost of providing such notice shall be paid out of the Settlement Fund.		
15	5.4 The Settlement Fund shall be applied as follows:

27	5.6 Each Person claiming to be an Authorized Claimant shall be required to submit to the		
28	Claims Administrator a completed Proof of Claim, substantially in the form of Exhibit A-2 attached

hereto, postmarked by no later than ninety (90) calendar days after the Notice Date (as defined in

 as are reasonably available to such Person.

5 5.7 Except as otherwise ordered by the Court, all Class Members who fail to submit a 6 Proof of Claim by the Bar Date, or such other period as may be ordered by the Court, or who submit a Proof of Claim that is rejected, shall be forever barred from receiving any payments pursuant to the 7 8 Stipulation and the Settlement set forth herein, but will in all other respects be subject to and bound 9 by the provisions of the Stipulation, the releases contained herein, and the Judgment. 10 Notwithstanding the foregoing, Lead Counsel shall have the discretion (but not the obligation) to accept late-submitted claims for processing so long as the distribution of the Net Settlement Fund to 11 12 Authorized Claimants is not materially delayed thereby.

- 5.8 The Claims Administrator shall calculate the claims of Authorized Claimants in
 accordance with the Plan of Allocation set forth in the Notice and approved by the Court. Following
 the Effective Date, the Claims Administrator shall send to each Authorized Claimant his, her, or its *pro rata* share of the Net Settlement Fund.
- 5.9 Defendants shall not have a reversionary interest in the Net Settlement Fund. If there
 is any balance remaining in the Net Settlement Fund after a reasonable amount of time following the
 date of the initial distribution of the Net Settlement Fund, Lead Counsel shall, if feasible, reallocate
 such balance among Authorized Claimants who negotiated the checks sent to them in the initial
 distribution in an equitable and economical fashion. These reallocations shall be repeated until the
 balance remaining in the Net Settlement Fund is *de minimis* and such remaining balance shall then
 be donated to the University of San Francisco School of Law's Investor Justice Clinic.
- 5.10 The Released Defendant Parties shall have no responsibility for, interest in, or
 liability whatsoever with respect to the processing, review, determination or calculation of any
 claims, the distribution of the Net Settlement Fund, the Plan of Allocation, the payment or
 withholding of Taxes, or any losses incurred in connection therewith.

5.11 Defendants shall take no position with respect to the Plan of Allocation or any other 1 2 such plan as may be approved by the Court.

3 5.12 It is understood and agreed by the Settling Parties that any proposed Plan of 4 Allocation of the Net Settlement Fund, including, but not limited to, any adjustments to an 5 Authorized Claimant's claim set forth therein, is not a part of the Stipulation and is to be considered by the Court separately from the Court's consideration of the fairness, reasonableness, and adequacy 6 of the Settlement set forth in the Stipulation, and any order or proceeding relating to the Plan of 7 8 Allocation shall not operate to terminate or cancel the Stipulation or affect the finality of the Court's 9 Judgment approving the Stipulation and the Settlement set forth therein, or any other orders entered 10 pursuant to the Stipulation. Class Members and Defendants shall be bound by the terms of this Stipulation, irrespective of whether the Court disapproves or modifies the Plan of Allocation. 11

12 5.13 No Person shall have any claim against Plaintiffs, the Class, Plaintiffs' Counsel, 13 Released Defendant Parties, Defendants' Counsel, or the Claims Administrator based on 14 distributions made substantially in accordance with the Settlement, the Stipulation, and the Plan of 15 Allocation, or otherwise as further ordered by the Court.

16

6. Lead Counsel's Attorneys' Fees and Expenses

17 6.1 Lead Counsel may submit an application or applications (the "Fee and Expense 18 Application") for: (a) an award of attorneys' fees; plus (b) expenses or charges in connection with 19 prosecuting the Action; plus (c) any interest on such attorneys' fees and expenses at the same rate 20 and for the same periods as earned by the Settlement Fund (until paid) as may be awarded by the 21 Court. Any and all such fees, expenses and costs awarded by the Court shall be payable solely out of 22 the Settlement Fund. In addition, Plaintiffs may submit an application for an award from the 23 Settlement Fund pursuant to 15 U.S.C. §78u-4(a)(4) in connection with their representation of the 24 Class.

25 6.2 The attorneys' fees and expenses, as awarded by the Court, shall be paid to Lead 26 Counsel from the Settlement Fund, as ordered, immediately upon entry of the Court's order 27 awarding such fees and expenses. This provision shall apply notwithstanding timely objection to, 28 potential for appeal from, or collateral attack on, the Settlement or the award of fees and expenses. 1 Lead Counsel shall thereafter allocate the attorneys' fees amongst other Plaintiffs' Counsel in a 2 manner that Lead Counsel in good faith believes reflects the contributions of such counsel to the 3 prosecution and resolution of the Action. Any such awards shall be paid solely by the Settlement 4 Fund. In the event that the Judgment or the order awarding such fees and expenses paid to Lead 5 Counsel pursuant to ¶6.1 and this ¶6.2 is reversed or modified, or if the Settlement is cancelled or terminated for any reason, then Lead Counsel shall, in an amount consistent with such reversal or 6 7 modification, refund such fees or expenses to the Settlement Fund pursuant to ¶2.9, plus the interest 8 earned thereon, within twenty-one (21) days from receiving notice from Defendants' counsel or from 9 a court of competent jurisdiction. Any refunds required pursuant to this paragraph shall be the 10 several obligation of each Plaintiffs' Counsel to make appropriate refunds or repayments to the Settlement Fund. Each Plaintiffs' Counsel, as a condition of receiving such fees or expenses on 11 12 behalf of itself and each partner and/or shareholder of it, agrees that its law firm and its partners 13 and/or shareholders are subject to the jurisdiction of the Court for the purpose of enforcing the 14 provisions of this paragraph.

6.3 The procedure for and the allowance or disallowance by the Court of the Fee and
Expense Application, to be paid out of the Settlement Fund, are not part of the Settlement set forth in
the Stipulation, and any order or proceeding relating to the Fee and Expense Application, or any
appeal from any order relating thereto or reversal or modification thereof, shall not operate to
terminate or cancel the Stipulation, or affect or delay the finality of the Judgment approving the
Stipulation and the Settlement of the Action.

6.4 Defendants shall not have any responsibility for any payment of attorneys' fees and
expenses to Lead Counsel or any Class Member's counsel apart from payment of the Settlement
Amount pursuant to ¶2.1.

24 25 7.

Conditions of Settlement, Effect of Disapproval, Cancellation, or Termination

7.1 The Effective Date of the Stipulation shall be conditioned on the occurrence of all of
 the following events:

(a) execution of the Stipulation and such other documents as may be required to
 obtain final Court approval of the Stipulation in a form satisfactory to the Settling Parties;

3 (b) certification of the Class and appointment of one or more of the Plaintiffs and
4 Lead Counsel as counsel for the Class;

(c) the Settlement Amount has been deposited into the Escrow Account;

6 (d) Defendants have not exercised their option to terminate the Stipulation
7 pursuant to ¶7.3 hereof;

8 (e) the Court has entered the Preliminary Approval Order, substantially in the
9 form of Exhibit A hereto, as required by ¶3.1 hereof;

(f) the Court has entered the Judgment that, *inter alia*, dismisses with prejudice
the Action, as to Lead Plaintiff and the Defendants, as set forth above; and

(g) the Judgment has become Final, as defined in ¶1.13 hereof.

13 7.2 Upon the occurrence of all of the events referenced in ¶7.1 hereof, any and all 14 remaining interest or right of Defendants in or to the Settlement Fund, if any, shall be absolutely and 15 forever extinguished. If all of the conditions specified in ¶7.1 hereof are not met, then the 16 Stipulation shall be canceled and terminated subject to ¶7.4 hereof unless Lead Counsel and counsel 17 for Defendants on behalf of their respective clients mutually agree in writing to proceed with the 18 Settlement.

19 7.3 If, prior to the Settlement Hearing, Persons who otherwise would be members of the 20 Class have timely and validly requested exclusion from the Class in accordance with the provisions 21 of the Preliminary Approval Order and the Notice given pursuant thereto, and if the total number of 22 shares of Impax common stock purchased or acquired by such Persons during the Class Period 23 equals or exceeds an amount specified in a separate Supplemental Agreement Regarding Requests for Exclusion ("Supplemental Agreement") executed between Lead Plaintiff and Defendants, then 24 25 Defendants shall have the option to terminate this Stipulation and Settlement in accordance with the 26 procedures set forth in the Supplemental Agreement. The Supplemental Agreement will not be filed 27 with the Court unless and until a dispute between Lead Plaintiff and Defendants concerning its 28 interpretation or application arises.

7.4 1 Unless otherwise ordered by the Court, in the event the Stipulation shall terminate, or 2 be canceled, or shall not become effective for any reason, within twenty-one (21) days after written 3 notification of such event is sent by counsel for Defendants or to the Escrow Agent, the Settlement 4 Fund (including accrued interest), less expenses which have either been incurred or disbursed 5 pursuant to ¶2.7 or 2.8 hereof, shall be refunded pursuant to written instructions from Defendants' Counsel to the party, parties or insurers that paid the Settlement Amount. At the request of counsel 6 7 for Defendants, the Escrow Agent or its designee shall apply for any tax refund owed on the 8 Settlement Fund and pay the proceeds, after deduction of any expenses incurred in connection with 9 such application(s) for refund, at the written direction of Defendants' Counsel to the party, parties or 10 insurers that paid the Settlement Amount.

7.5 In the event that the Stipulation is not approved by the Court or the Settlement set 11 forth in the Stipulation is terminated or fails to become effective in accordance with its terms, the 12 13 Settling Parties shall be restored to their respective positions in the Action as of June 27, 2021. In 14 such event, the terms and provisions of the Stipulation, with the exception of ¶1.1-1.41, 2.7-2.8, 15 7.2, and 8.3 hereof, shall have no further force and effect with respect to the Settling Parties and 16 shall not be used in this Action or in any other proceeding for any purpose, and any Judgment or 17 order entered by the Court in accordance with the terms of the Stipulation shall be treated as vacated, 18 nunc pro tunc, and the Settling Parties shall be deemed to return to their status as of June 27, 2021. 19 No order of the Court or modification or reversal on appeal of any such order of the Court 20 concerning the Plan of Allocation or the amount of any attorneys' fees and expenses, and interest 21 awarded by the Court to Lead Counsel or Plaintiffs shall constitute grounds for cancellation or 22 termination of the Stipulation.

7.6 If, before the Settlement becomes Final, any Defendant files for protection under the
Bankruptcy Code, or any similar law, or a trustee, receiver, conservator, or other fiduciary is
appointed under bankruptcy, or any similar law, and in the event of the entry of a final order of a
court of competent jurisdiction determining the transfer of money or any portion thereof to the
Escrow Agent by or on behalf of any Defendant to be a preference, voidable transfer, fraudulent
transfer or similar transaction and any portion thereof is required to be returned, and such amount is

not promptly deposited with the Escrow Agent by others, then, at the election of Plaintiffs, the
 Settling Parties shall jointly move the Court to vacate and set aside the release given and the
 Judgment entered in favor of the Defendants and that the Defendants and Plaintiffs and the members
 of the Class shall be restored to their litigation positions as of June 27, 2021.

Miscellaneous Provisions

8.1 The Settling Parties (a) acknowledge that it is their intent to consummate this
7 Stipulation; and (b) agree to cooperate to the extent reasonably necessary to effectuate and
8 implement all terms and conditions of the Stipulation and to exercise their best efforts to accomplish
9 the foregoing terms and conditions of the Stipulation expeditiously.

10 8.2 The Settling Parties intend this Settlement to be a final and complete resolution of all disputes between them with respect to the Action. The Settlement shall not be deemed an admission 11 by any Settling Party or any of the Released Parties as to the merits of any claim or defense. The 12 13 Settling Parties and their counsel agree that they shall not assert any claims of any violation of Rule 14 11 of the Federal Rules of Civil Procedure relating to the institution, prosecution, defense or 15 settlement of the Action, and the Final Judgment shall contain a finding that all Settling Parties and 16 their counsel complied with the requirements of Rule 11 with respect to the institution, prosecution, 17 defense, and resolution of the Action. The Settling Parties agree that the amount paid to the 18 Settlement Fund and the other terms of the Settlement were negotiated in good faith at arm's length 19 by the Settling Parties and reflect a settlement that was reached voluntarily after consultation with 20 competent legal counsel. The Settling Parties reserve their right to rebut, in a manner that such party 21 determines to be appropriate, any contention made in any public forum regarding the Action, 22 including that the Action was brought or defended in bad faith or without a reasonable basis.

23 8.3 Neither the Stipulation nor the Settlement contained herein, nor any act performed or 24 document executed pursuant to or in furtherance of the Stipulation or the Settlement: (a) is or may be 25 deemed to be or may be used as an admission of, or evidence of, the validity of any Released Claim, 26 or of any wrongdoing or liability of the Released Defendant Parties; or (b) is or may be deemed to be 27 or may be used as an admission of, or evidence of, any fault or omission of any of the Released 28 Defendant Parties; or (c) is or may be deemed to be or may be used as an admission or evidence that AMENDED STIPULATION OF SETTLEMENT - 4:16-cv-06557-HSG - 21 4837-2117-0943.v1

any claims asserted by Plaintiffs were not valid or that the amount recoverable was not greater than
the Settlement Amount, in any civil, criminal, or administrative proceeding in any court,
administrative agency, or other tribunal. The Released Defendant Parties may file the Stipulation
and/or the Judgment in any action that may be brought against them in order to support a defense or
counterclaim based on principles of *res judicata*, collateral estoppel, release, good faith settlement,
judgment bar or reduction or any other theory of claim preclusion or issue preclusion or similar
defense or counterclaim.

8 8.4 Whether or not the Stipulation is approved by the Court and whether or not the
9 Stipulation is consummated, or the Effective Date occurs, the Parties and their counsel shall use their
10 best efforts to keep all negotiations, discussions, acts performed, agreements, drafts, documents
11 signed and proceedings in connection with the Stipulation confidential.

12 8.5 All agreements made and orders entered during the course of the Action relating to
13 the confidentiality of documents and information shall survive this Stipulation.

14 8.6 All of the Exhibits to the Stipulation are material and integral parts hereof and are15 fully incorporated herein by this reference.

16 8.7 The Stipulation may be amended or modified only by a written instrument signed by
17 or on behalf of all Settling Parties or their respective successors-in-interest.

8.8 No waiver of any term or provision of this Stipulation, or of any breach or default
hereof or hereunder, shall be valid or effective unless in writing and signed by or on behalf of all
Settling Parties or their respective successors-in-interest. No waiver of any term or provision of this
Stipulation, or of any breach or default hereof or hereunder, shall be construed as a waiver of the
same or any other term or provision or of any previous or subsequent breach thereof.

8.9 The Stipulation and the Exhibits attached (together with the Supplemental Agreement
referred to in ¶7.3) hereto constitute the entire agreement among the Settling Parties and no
representations, warranties, or inducements have been made to any Settling Party concerning the
Stipulation or its Exhibits other than the representations, warranties, and covenants contained and
memorialized in such documents. Except as otherwise provided herein (or, as between Defendants,
in any separate agreements between them), each Settling Party shall bear its own costs.

8.10 The Settlement is not conditioned upon the settlement or approval of settlement of
 any derivative suits or other suits.

8.11 This Stipulation shall be construed and interpreted to effectuate the intent of the
Settling Parties, which is to resolve completely those claims and disputes, including in the Action,
and as more fully described herein. If any provision of this Stipulation shall be determined to be
invalid, void, or illegal, such provision shall be construed and amended in a manner that would
permit its enforcement, but in no event shall such provision affect, impair, or invalidate any other
provision hereof.

9 8.12 Neither the Class Members nor Defendants shall be bound by the Stipulation if the 10 Court modifies material terms thereof; provided, however, that it shall not be a basis for Class Members to terminate the Settlement if the Court modifies any proposed Plan of Allocation or 11 12 criteria for allocation of the Net Settlement Fund amongst Authorized Claimants, or the Plan of 13 Allocation is modified on appeal. 21 effectuate its terms and also is expressly authorized to enter into any modifications or amendments to
22 the Stipulation on behalf of the Class which it deems appropriate.

5. Pursuant to Rule 23 of the Federal Rules of Civil Procedure, and for purposes of

Reasons made materially false and misleading statements about Impax's business performance and conditions. More specifically, Plaintiffs allege that during the Class Period, Defendants misled investors regarding Impax's collusion with pharmaceutical industry peers to fix generic drug prices and the impact of competition and price erosion on its sales of certain key products in its generics portfolio. 14. Plaintiffs allege that during the Class Period, Defendants knew or recklessly disregarded that Impax's profits were inflated by collusive agreements with the Company's peers to fix the prices of digoxin and pyridostigmine bromide. Plaintiffs further allege that, pursuant to the industrywide conspiracy's "rules of the road," Impax was required to, and did, cede market share to manufacturers as they entered the market in order to maintain supracompetitive pricing. As a result, Impax reported declines in gross margins attributed to, in large part, a decline in digoxin sales on May 11, 2015 after the market closed. Impax also announced that the Antitrust Division of the DOJ had issued a grand jury subpoena to Impax relating to price fixing of four generic drugs, including digoxin. Following the May 11 disclosures, Impax's stock price declined 2.7% or \$1.10 per share at closing on May 12, 2015. On August 10, 2015, Impax announced a reduction in gross margin guidance from mid-50% to low-50%, allegedly due to pressure on digoxin, causing Impax's stock price to decline 3% or \$2.07 per share. Plaintiffs allege that Defendants partia

particularly diclofenac, resulting in lower revenues and gross margins. That day, Impax common stock declined 11% or \$3.53 per share, and its 2% Convertible Senior Notes declined \$40 per \$1,000 par value. On August 9, 2016, Impax announced quarterly results and provided updated guidance that reduced forecasted revenues by \$49 to \$89 million, with analysts attributing at least a substantial portion to diclofenac. Digoxin revenues also declined, contributing an estimated 15% to the revenue shortfall. Impax's stock price declined 23% or \$7.29 per share, and its 2% Convertible Senior Notes declined \$78 per \$1,000 par value.

- 15. On October 26, 2018, Lead Plaintiff filed its Second Amended Complaint for Violation of the Federal Securities Laws. On December 6, 2018, Defendants moved to dismiss this complaint, which was opposed by Lead Plaintiff. On August 12, 2019, the Court issued an order granting Defendants' motion to dismiss. The United States Court of Appeals for the Ninth Circuit affirmed in part and reversed in part this decision on January 11, 2021.
- 16. In the course of the Litigation, the Settling Parties engaged the services of the Hon. Layn Phillips (Ret.), of Phillips ADR, a nationally recognized mediator. The Settling Parties engaged in a mediation session with Judge Phillips on September 17, 2020. While the Settling Parties did not reach an agreement to settle the Litigation at the mediation, the Settling Parties continued settlement negotiations with the assistance of Judge Phillips, who provided the Settling Parties with a Mediator's Proposal on June 26, 2021. The Settling Parties each accepted the Mediator's Proposal to settle the Litigation for \$33 million.

WHAT ARE PLAINTIFFS' REASONS FOR THE SETTLEMENT?

28

18. Plaintiffs and Lead Counsel believe that the claims asserted against Defendants

have merit. Plaintiffs and Lead Counsel recognize, however, the expense and length of continued proceedings necessary to pursue their claims against Defendants through trial and appeals, as well as the difficulties in establishing liability, obtaining class certification and establishing damages.
Plaintiffs and Lead Counsel have considered the amount of the Settlement, as well as the uncertain outcome and risk in complex lawsuits like this one. Such risks include, in particular, the risk that another motion to dismiss that Defendants filed after the Ninth Circuit's decision would be granted and the risk, among others, that Plaintiffs would be unsuccessful in proving that Defendants' alleged misstatements were materially false and misleading, made with scienter (that is, the requisite state of mind), or caused compensable damages to the Class.

19. In light of the amount of the Settlement and the immediacy of recovery to the Class, Plaintiffs and Lead Counsel believe that the proposed Settlement is fair, reasonable and adequate, and in the best interests of the Class. Plaintiffs and Lead Counsel believe that the Settlement provides a substantial benefit now, namely \$33 million in cash (less the various deductions described in this Notice), as compared to the risk that the claims would produce a smaller recovery, or no recovery after summary judgment, trial and appeals, possibly years in the future.

20. Defendants have denied and continue to deny each and all of the claims alleged by
 Plaintiffs in the Litigation. Defendants expressly have denied and continue to deny all charges of
 wrongdoing or liability against them arising out of any of the conduct, statements, acts or
 omissions alleged, or that could have been alleged, in the Litigation. Defendants also have denied
 and continue to deny, among other things, the allegations that Plaintiffs or the Class have suffered
 any damage, that Plaintiffs or the Class were harmed by the conduct alleged in the Litigation, or
 that the Litigation is properly certifiable as a class action for litigation purposes.

WHAT MIGHT HAPPEN IF THERE WERE NO SETTLEMENT?

17 21. If there were no Settlement and Plaintiffs failed to establish any essential legal or
 factual element of the alleged claims, neither Plaintiffs nor the Class would recover anything from
 Defendants. If Plaintiffs were not to succeed in obtaining class certification, Defendants may
 have asserted the defense that the claims of Class Members were untimely under applicable
 statutes of limitations and statutes of repose. Also, if Defendants were successful in proving any
 of their defenses, the Class likely would recover substantially less than the amount provided in the
 Settlement, or nothing at all.

HOW MUCH WILL MY PAYMENT BE?

22 Defendants have agreed to cause to be paid Thirty-Three Million Dollars
 (\$33,000,000.00) in cash into escrow for the benefit of the Class. At this time, it is not possible to make any determination as to how much individual Class Members may receive from the Settlement. Plaintiffs have proposed a plan for allocating the Net Settlement Fund to those Class Members who timely submit valid Proof of Claim Forms. The Plan of Allocation proposed by Plaintiffs is set forth below, and additional information is available on the website created for purposes of this Settlement, www.ImpaxSecuritiesSettlement.com.



39. Option contracts are not securities eligible to participate in the Settlement. With respect to Impax common stock purchased or sold through the exercise of an option, the purchase/sale date of the common stock is the exercise date of the option and the purchase/sale price of the common stock is the exercise price of the option.

To the extent a claimant had a market gain with respect to his, her, or its overall 12 transactions in Impax common stock or Convertible Senior Note during the Class Period, the 13 value of the claimant's Recognized Claim shall be zero. WHAT RIGHTS AM I GIVING UP BY AGREEING TO THE SETTLEMENT?

The Judgment will dismiss with prejudice the claims against Defendants and will provide that 11 Plaintiffs, and all other Released Plaintiff Parties (as defined in ¶48 below) shall have waived, released, discharged, and dismissed each and every one of the Released Claims (as defined in ¶45 12 below), including Unknown Claims (as defined in ¶49 below), against each and every one of the Released Defendant Parties (as defined in ¶47 below) and shall forever be barred and enjoined 13 from commencing, instituting, prosecuting, or maintaining any and all of the Released Claims 14 against any and all of the Released Defendant Parties, whether or not they execute and deliver the Claim Form or share in the Settlement Fund. Claims to enforce the terms of the Settlement are 15 not released.

"Released Plaintiff Parties" means the Plaintiffs, each and every Class Member, Plaintiffs' Counsel, and each of their respective past or present trustees, officers, directors, 3 partners, employees, contractors, auditors, principals, agents, attorneys, predecessors, successors, assigns, insurers, parents, subsidiaries, general or limited partners or partnerships, and limited 4 liability companies; and the spouses, members of the immediate families, representatives, and heirs of any Released Plaintiff Party who is an individual, as well as any trust of which any 5 Released Plaintiff Party is the settlor or which is for the benefit of any of their immediate family 6 members. Released Plaintiff Parties does not include any Person who timely and validly seeks exclusion from the Class.

7

49. "Unknown Claims" means any and all Released Claims that Plaintiffs or any other 8 Class Member do not know or suspect to exist in his, her, or its favor at the time of the release of the Released Defendant Parties, and any and all Released Defendants' Claims that any Defendant 9 does not know or suspect to exist in his, her or its favor, which if known by him, her or it, might 10 have affected his, her or its decision to enter into this Settlement, execute the Stipulation, and agree to all the various releases set forth herein, or might have affected his, her or its decision not 11 to object to this Settlement or not exclude himself, herself or itself from the Class. Unknown Claims include, without limitation, those claims in which some or all of the facts composing the 12 claim may be unsuspected, undisclosed, concealed, or hidden. With respect to any and all Released Claims and Released Defendants' Claims, the Released Parties stipulate and agree that, 13 upon the Effective Date, Plaintiffs and Class Members (as regards the Released Claims) and the 14 Defendants (as regards the Released Defendants' Claims) shall expressly waive and relinquish, and each Class Member shall be deemed to have and by operation of law and of the Judgment 15 shall have, expressly waived and relinquished, to the fullest extent permitted by law, any and all provisions, rights and benefits conferred by California Civil Code §1542, or any law of any state 16 or territory of the United States, or principle of common law or of international or foreign law, which is similar, comparable, or equivalent to Cal. Civ. Code §1542, which provides: 17

A general release does not extend to claims which the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.

WHAT PAYMENT ARE THE ATTORNEYS FOR THE CLASS SEEKING? HOW WILL THE LAWYERS BE PAID?

51. Lead Counsel has not received any payment for its services in pursuing claims 1 against Defendants on behalf of the Class, nor has Lead Counsel been paid for its expenses. 2 Before final approval of the Settlement, Lead Counsel intends to apply to the Court for an award of attorneys' fees on behalf of all Plaintiffs' Counsel from the Settlement Fund of no more than 3 30% of the Settlement Amount, plus interest. Pursuant to Rule 23 of the Federal Rules of Civil Procedure, the Court hereby 13 affirms its determinations in the Preliminary Approval Order, which certified, for purposes of 14 effectuating the Settlement, a Class defined as all Persons that purchased or acquired Impax 15 common stock or 2% Convertible Senior Notes between February 20, 2014 and August 9, 2016, 16 inclusive. Excluded from the Class are: (i) Defendants; (ii) members of the immediate families 17 of the Individual Defendants; (iii) Impax's subsidiaries; (iv) the officers and directors of Impax 18 during the Class Period; (v) any entity in which any Defendant has a controlling interest; and (vi) 19 the legal representatives, heirs, successors and assigns of any such excluded person or entity. Also 20 excluded from the Class will be any Person who timely and validly seeks exclusion from the Class.
- 21 4. With respect to the Class, this Court finds for the purposes of effectuating the 22 Settlement that: (a) the members of the Class are so numerous that joinder of all Class Members 23 in the Action is impracticable; (b) there are questions of law and fact common to the Class; (c) the claims of the Plaintiffs are typical of the claims of the Class; (d) Plaintiffs, and their counsel have 24 25 fairly and adequately represented and protected the interests of the Class Members; (e) the 26 questions of law and fact common to the Class predominate over any questions affecting only 27 individual members of the Class; and (f) a class action is superior to other available methods for 28 the fair and efficient adjudication of the controversy, considering: (i) the interests of the members FINAL JUDGMENT AND ORDER OF DISMISSAL WITH PREJUDICE EXHIBIT B - 4:16-cv-06557-HSG - 1 4838-4172-2865.v2

1 of the Class in individually controlling the prosecution of the separate actions; (ii) the extent and 2 nature of any litigation concerning the controversy already commenced by members of the Class; 3 (iii) the desirability or undesirability of concentrating the litigation of these claims in this particular 4 forum; and (iv) the difficulties likely to be encountered in the management of the Action.

5 5. Pursuant to Rule 23 of the Federal Rules of Civil Procedure, the Court certifies 6 Sheet Metal Workers' Pension Plan of Southern California, Arizona & Nevada as the 7 representative of the Class. Lead Counsel are also certified as counsel to the class representatives, 8 and the Class in the Action.

9 6. Pursuant to Rule 23 of the Federal Rules of Civil Procedure, this Court hereby 10 approves the Settlement set forth in the Stipulation and finds that:

11 the Stipulation and the Settlement contained therein are, in all respects, fair, (a) 12 reasonable and adequate;

(b) there was no collusion in connection with the Stipulation;

14 the Stipulation was the product of informed, arm's-length negotiations (c) 15 among competent, able counsel; and

16 (d) the record is sufficiently developed and complete to have enabled Plaintiffs 17 and Defendants to have adequately evaluated and considered their positions.

18 7. Accordingly, the Court authorizes and directs implementation and performance of all the terms and provisions of the Stipulation, as well as the terms and provisions hereof. Except 19 20 as to any individual claim of those Persons who have validly and timely requested exclusion from 21 the Class (identified in Exhibit 1 hereto), the Action and all claims contained therein are dismissed 22 with prejudice as to the Plaintiffs, and the other Class Members and as against each and all of the 23 Released Defendant Parties. The Settling Parties are to bear their own costs except as otherwise provided in the Stipulation. 24

25 8. No Person shall have any claim against the Plaintiffs, Lead Counsel, or the Claims Administrator, or any other Person designated by Lead Counsel based on determinations or 26 27 distributions made substantially in accordance with the Stipulation and the Settlement contained 28 therein, the Plan of Allocation, or further order(s) of the Court. 9. Upon the Effective Date, the Plaintiffs, and each of the Class Members shall be 1 2 deemed to have, and by operation of this Judgment shall have, fully, finally and forever waived, 3 released, discharged, and dismissed each and every one of the Released Claims against each and 4 every one of the Released Defendant Parties with prejudice on the merits, whether or not the 5 Plaintiffs, or such Class Member executes and delivers the Proof of Claim and whether or not the Plaintiffs, or each of the Class Members ever seeks or obtains any distribution from the Settlement 6 7 Fund. Claims to enforce the terms of the Stipulation are not released.

8 10. Upon the Effective Date, the Defendants and each and every Released Defendant 9 Party shall be deemed to have, and by operation of this Judgment shall have, fully, finally and 10 forever waived, released, discharged, and dismissed the Released Plaintiff Parties from all Released Defendants' Claims (including, without limitation, Unknown Claims). Claims to enforce 11 12 the terms of the Stipulation are not released.

13

11. Upon the Effective Date, the Plaintiffs, all Class Members and anyone claiming 14 through or on behalf of any of them are forever barred and enjoined from commencing, instituting, 15 asserting or continuing to prosecute any action or proceeding in any court of law or equity, 16 arbitration tribunal, administration forum or other forum of any kind any of the Released Claims 17 (including, without limitation, Unknown Claims) against any of the Released Defendant Parties.

18 12. The distribution of the Notice and publication of the Summary Notice as provided 19 for in the Preliminary Approval Order constituted the best notice practicable under the 20 circumstances, including individual notice to Class Members who could be identified through 21 reasonable effort. The notice provided was the best notice practicable under the circumstances of 22 those proceedings and of the matters set forth therein, including the proposed Settlement set forth 23 in the Stipulation, to all Persons entitled to such notice, and said notice fully satisfied the 24 requirements of Federal Rule of Civil Procedure 23, due process and any other applicable law, 25 including the Private Securities Litigation Reform Act of 1995. No Class Member is relieved from 26 the terms of the Settlement, including the releases provided for therein, based upon the contention 27 or proof that such Class Member failed to receive actual or adequate notice. A full opportunity 28 has been offered to the Class Members to object to the proposed Settlement and to participate in FINAL JUDGMENT AND ORDER OF DISMISSAL WITH PREJUDICE EXHIBIT B - 4:16-cv-06557-HSG - 3 4838-4172-2865.v2

the hearing thereon. The Court further finds that the notice provisions of the Class Action Fairness
 Act, 28 U.S.C. Section 1715, were fully discharged and that the statutory waiting period has
 elapsed. Thus, it is hereby determined that all members of the Class are bound by this Judgment,
 except those persons listed on Exhibit 1 to this Judgment.

5 13. Any Plan of Allocation submitted by Lead Counsel or any order entered regarding 6 any attorneys' fee and expense application shall in no way disturb or affect this Judgment and shall 7 be considered separate from this Judgment. Any order or proceeding relating to the Plan of 8 Allocation or any order entered regarding any attorneys' fee and expense application, or any appeal 9 from any order relating thereto or reversal or modification thereof, shall not affect or delay the 10 finality of the Final Judgment in this Action.

14. Neither the Stipulation nor the Settlement contained therein, nor any act performed 11 12 or document executed pursuant to or in furtherance of the Stipulation or the Settlement: (a) is or 13 may be deemed to be or may be used as an admission of, or evidence of, the validity of any 14 Released Claim or of any wrongdoing or liability of the Released Defendant Parties; or (b) is or 15 may be deemed to be or may be used as an admission of, or evidence of, any fault or omission of 16 any of the Released Defendant Parties; or (c) is or may be deemed to be or may be used as an 17 admission or evidence that any claims asserted by Lead Plaintiff were not valid or that the amount 18 recoverable was not greater than the Settlement Amount in any civil, criminal or administrative 19 proceeding in any court, administrative agency or other tribunal. The Released Defendant Parties 20 may file the Stipulation and/or this Judgment in any other action that may be brought against them 21 in order to support a defense or counterclaim based on principles of res judicata, collateral 22 estoppel, release, good faith settlement, judgment bar or reduction, or any other theory of claim 23 preclusion or issue preclusion or similar defense or counterclaim.

15. Without affecting the finality of this Judgment in any way, this Court hereby retains
continuing jurisdiction over: (a) implementation of the Settlement and any award or distribution
of the Settlement Fund, including interest earned thereon; (b) disposition of the Settlement Fund;
(c) hearing and determining applications for attorneys' fees and expenses in the Action; and (d) all
parties hereto for the purpose of construing, enforcing and administering the Settlement.

5	terms of the Stipulation, or the Effective Date does not occur, or in the event that the Settlement				
6	Fund, or any portion thereof, is returned to the Defendants or their insurers, then this Judgment				
7	shall be rendered null and void to the extent provided by and in accordance with the Stipulation				
8	and shall be vacated; and in such event, all orders entered and releases delivered in connection				
9	herewith shall be null and void to the extent provided by and in accordance with the Stipulation.				
10	18. The Settling Parties shall bear their own costs and expenses except as otherwise				
11	provided in the Stipulation or in this Judgment.				
12	19. Without further order of the Court, the Settling Parties may agree to reasonable				
13	extensions of time to carry out any of the provisions of the Stipulation.				
14	20. The Court directs immediate entry of this Judgment by the Clerk of the Court.				
15	21. The Court's orders entered during this Action relating to the confidentiality of				
16	information shall survive this Settlement.				
17	IT IS SO ORDERED.
